## BERTH APPLICATION PROCEDURES & POLICIES

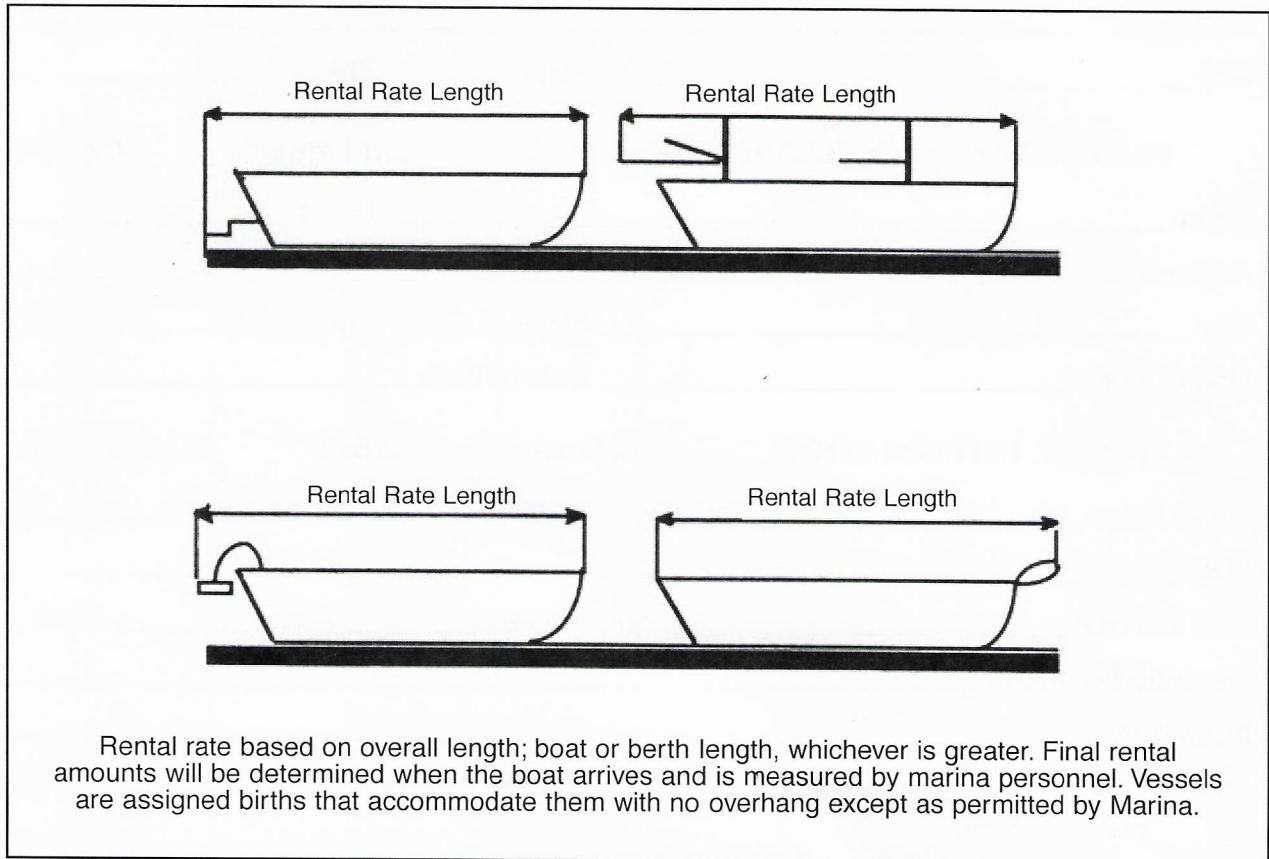
**Procedures:** The following should be submitted with the application.

- Photo of the Boat
- A copy of the current vessel registration/documentation or a copy of the bill of sale.
- A certificate of insurance naming Marina as additional insured and showing \$300,000 liability coverage.
- Boats older than 15 years will require a survey completed within the last 24 months.

**Policies:** Mooring Agreement will be executed when all required documents are received.

- First month's rent is due on the date of move in.
- A written vacate notice must be received 30 days prior to date of vacating.
